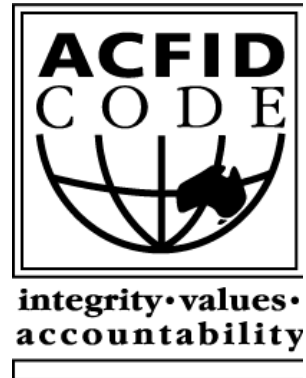

ACFID Code of Conduct

The voluntary, self regulatory industry Code for international non-government development organisations

What is the Code?

The ACFID Code of Conduct represents the active commitment of its signatories to conduct their activities with accountability and integrity.

It defines standards of best practice for international development organisations in the fields of:

- organisational integrity;
- governance;
- communication with the public;
- finances; and
- personnel and management practice.

The Code of Conduct was launched by Governor General Sir William Deane in 1998.

Compliance with the Code

A Code of Conduct Committee monitors adherence to the Code and investigates complaints. Currently compliance with the Code is monitored in three ways:

- (1) assessment of annual reports and financial statements;
- (2) investigation of inquiries and complaints;
- (3) ad hoc monitoring in the wake of natural disasters.

The Code Committee works in partnership with the aid and development sector to enhance the sector's transparency, accountability and standards.

Why become a Signatory?

Strengthen your organisation

The Code of Conduct represents the active commitment of Signatories to achieve best practice. Not simply a set of written standards, the Code applies to all aspects of a Signatory's work.

Donor confidence

By being a Code Signatory, your organisation is easily identified as a transparent, accountable organisation. Through open and accurate reporting, in your organisations annual report and financial statements, the donor can be assured their money is being spent as agreed.

Access to Code of Conduct Committee and Code Management Team Expertise

The Code Management Team (CMT) assists the Code of Conduct Committee in all aspects of its work; and assists Signatories to meet their compliance obligations. Signatories are encouraged to contact the CMT to clarify any issues of concern, provide feedback on issues relating to the Code, or to access Code resources.

Use of the Code Logo

Being able to display the Code of Conduct logo on your organisational documents easily identifies your organisation as one that takes accountability seriously and is committed to achieving best practice within the international aid and development community.

Being a Code Signatory: the first step

Is your organisation Australian? voluntary? and not-for-profit? Does it conduct activities in the international aid and development sector? If you answered yes to all of these, your organisation may apply to become a Signatory to the ACFID Code of Conduct.

Complete the *Code of Conduct Signatory Application Form* and submit it to the Code Management Team with the following documents:

- Constitution or Governing Instrument
- Most recent Annual Report
- Most recent *audited* financial statements
- Compliant Child Protection Policy
- Compliant Gender Equity Policy
- Completed Compliance Self Assessment Checklist and Action Plan
